THE ROOF GUYS warrants to the general contractor or homeowner their new asphalt shingle roof will be free from defect in workmanship that may cause leakage or the loss of shingles. THE ROOF GUYS will repair such problems, by supplying labor for the lifetime of the roof. The warranty items are to be repaired only by THE ROOF GUYS and the customer must notify THE ROOF GUYS within seven (7) days after the problem has been discovered.

The warranty is non-transferable and THE ROOF GUYS will not be liable for the roof or structural damage resulting from normal wear and tear, including but not limited to ice damage, hailstorms or foreign objects. In addition, any fungus, bacteria, infestation, UV degradation, rust or corrosion resulting in metal or wood decay regardless of proximate cause will not be covered by this warranty.

THIS WARRANTY IS IN LIEU OF ALL OTHER EXPRESS AND IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND IS LIMITED TO THE DURATION AND TERMS OF THIS WARRANTY. THE ROOF GUYS SHALL NOT BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES OF ANY FORM. THIS INCLUDES DAMAGE TO THE INTERIOR OR EXTERIOR OF ANY BUILDING OR REPLACEMENT OR MODIFICATION TO THE ORIGINAL WORK (TO INCLUDE BUT NOT LIMITED TO SOLAR PANEL INSTALLATION) NOT AUTHORIZED IN WRITING OR PERFORMED BY THE ROOF GUYS. ANY REPAIRS ALLOWABLE UNDER THIS WARRANTY SHALL NOT BE CONSTRAINED IN ANY WAY BY MATCHABILITY CONCERNS REGARDING NECESSARY REPLACEMENT PRODUCTS.

To obtain services, the general contractor/homeowner must have their contract amount paid in full. Secondly, present this certificate of warranty, and THE ROOF GUYS will respond within seven (7) working days.
